I am pleased to share the progress made by Charutar Arogya Mandal over the past year.



#### Life's Fragile Beginnings

Preterm babies face incredible challenges, but the support from donors helps them overcome those hurdles. Two preterm babies, from impoverished backgrounds, with extremely low birth weight and breathing difficulties found hope at Shree Krishna Hospital. With the dedicated care of our Neonatologists, these fragile infants gained weight and learned to breathe on their own. Their parents would not have been able to afford medical bills and the infrastructure required to help give their children the medical care they need. Generous contributions help us give these tiny fighters a fighting chance.

#### Life-Saving Surgery for a Nigerian child

Our commitment to providing world-class healthcare extends beyond borders. When a two-year-old Nigerian child with congenital heart disease and Down Syndrome needed life-saving heart surgery, they found hope at our Hospital's Cardiac Centre.

#### Fighting a Cancer in kidney, Reviving Hope

Cancer doesn't discriminate by age, and when a 17-year-old girl faced a cancerous tumor in her kidney, our Cancer Centre team stepped in. This young life was in unbearable pain, and the tumor was threatening her vital organs. Our experts performed a radical nephrectomy, removing the tumor in kidney. A part of treatment cost was covered under the Ayuhshman Yojana, while the rest was mitigated by our donors.

#### Life-Saving Lung Surgery for 12-Year-Old

Imagine being a parent with your child's life hanging in the balance. Our team at Shree Krishna Hospital performed a miracle by removing a rare hydatid cyst from the right lung of a 12-year-old patient. This condition is so rare that it affects just one in every 1,00,000 individuals worldwide. Thanks to the expertise of our Surgeons, not only was the cyst successfully removed, but it was done so intact, avoiding any complications or toxic spillage.

#### Breaking Heart Blockage with Advanced Technology

In the world of cardiology, breakthroughs can mean the difference between life and death. Thanks to the cutting-edge ROTAPRO TRIPSY technique at our Cardiac Centre, we gave an 87-year-old patient a new lease on life. The technology, used for the first time in our region, removed heavy calcifications in blood vessels, ensuring the best outcome for our high-risk patient.

#### Saving Hearts, Saving Lives

A ten-year-old child with rheumatic heart disease faced a bleak future until our Pediatric Cardiologist diagnosed the condition and recommended surgery. Thanks to the expertise of our medical team, which included a Pediatric Thoracic Surgeon and Vascular Surgeon, the child underwent a successful Aortic Valve Repair, offering a brighter future.





Pioneering Heart Surgery Technique

Innovation in medicine saves lives, and your contributions make it possible. Our Cardiac Centre became the first in the region to use the TEVAR technique to treat a ruptured aorta. This non-surgical procedure, easily available in larger cities, was successfully performed right here, saving a 55-year-old lady's life.



Chronic conditions can be debilitating, but your support makes miracles happen. Our Urologist transformed the life of a 45-year-old patient suffering from severe bladder pain. Through augmentation cystoplasty, using intestine from his abdomen to enlarge the urinary bladder, the patient's pain was relieved, and his life restored.

#### Mothers' Miraculous Recoveries

Two pregnant mothers arrived at our hospital in dire circumstances, with little hope of survival for themselves or their unborn children. Massive blood loss and complications threatened their lives. Through expert care, including intensive care and blood transfusions, these mothers were brought back from the brink, going home healthy to nurture their families.

#### Resuscitating Hearts, Restoring Hope

Imagine a mother's heart-stopping immediately after childbirth. It's a nightmare, but your support helps us turn these nightmares into stories of triumph. Our Intensivists performed CPR to revive her heart and provided essential life support. After a lengthy stay and meticulous care, she went home healthy, ready to embrace her newborn.

These compelling impact stories are a testament to the incredible work being done at our hospital. Each life saved, each condition treated, is made possible by your generosity and compassion. Together, we are making a difference and giving hope to those in need.



#### **Expanding Horizons**

From its modest beginnings with a small nursing school, the Mandal has grown into a formidable force in healthcare and education. It now boasts a 1000-bed NABH-accredited multi-speciality hospital, a Cancer Centre, a Bone Marrow Transplant Unit, a Cardiac Centre, and a Critical Care Centre with 102 ICU beds. The Mandal also operates six institutions offering over 82 undergraduate and post-graduate courses in medicine, physiotherapy, nursing, and allied health sciences.

#### Impact

But what truly defines the Mandal is its unwavering commitment to the community. Each year, over 5,05,000 patients seek outdoor consultations, 50,000 are admitted to various indoor services, and 11,000 undergo surgeries at the Hospital. No one is turned away due to an inability to pay; indigent patients receive the same high-quality care as those who can afford it. The Aashirwad scheme ensures that healthcare remains affordable, allowing for concessional costs in outpatient, in-patient, and emergency services.

#### Collaboration for Impact

Charutar Arogya Mandal collaborates with the government on schemes like Ayushman Bharat and Mukhyamantri Amrutam (MA) Yojana. This collaboration extends support to a larger number of patients in need, even though it often results in significant financial losses due to fixed compensation rates that barely cover treatment costs.

# Community Outreach

The Mandal's SPARSH program is a lifeline to rural communities, connecting them to appropriate healthcare through a team of trained Village Health Workers, Medical Officers, Social Workers and para medics. We have been running the Shree Krishna Hospital Programme for Advancement in Social and Rural Health (SPARSH) program since 2015-16 based on a community-based NCD (Non-Communicable Disease) healthcare model. Covering 150 villages and a population of 4.50 lakhs, SPARSH focuses on preventing, treating, and caring for chronic diseases. Bi-monthly health camps in villages, held in public locations like Anganwadis, Schools, Gram Panchayats, offer free consultations and screenings, with affordable medication. Diagnostic services, doorstep medication delivery, and follow-ups by Village Health Workers are an integral part of the initiative.

Currently, SPARSH serves 2,178 patients, and a recent impact evaluation found a 90% improved control rate through medication adherence.



## Charting New Frontiers in Comprehensive Primary Healthcare: The Innovation and Learning Centre (ILC)

In 2018, Charutar Arogya Mandal embarked on a transformative journey with the establishment of the Innovation and Learning Centre (ILC). This pioneering initiative emerged in response to a call for proposals from the National Health System Resource Centre (NHSRC) in New Delhi, which handpicked CAM as its very first Innovation and Learning Centre in India.

#### Covering an expansive landscape of 62 Sub-health Centres, the ILC's reach extends to Health and Wellness Centres in the Dahod block, catering to a population of 400,000.

At the heart of the ILC's strategy is a hands-on approach, offering unwavering support to frontline health workers at Health & Wellness Centres - HWCs through guided supervision and promoting policy advocacy for the seamless execution of CPHC within the National Health Mission. Notable achievements have already marked this journey, as a team from NHSRC and RRC-NE (Regional Resource Centre-Northeast) commended the activities conducted by the CPHC-ILC at Bhaikaka University during their visit in March 2023.

Bhaikaka University was entrusted with the significant responsibility of compiling the Ayushman Bharat - Health and Wellness Centre (AB-HWC) Assessment report for 10 states across India, a task accomplished with distinction.

As we continue our journey of innovation and learning, the ILC remains committed to its mission of advancing comprehensive primary healthcare.

# Nourishing Lives: A Gift of Health and Happiness

Celebrating the 5th Rashtriya Poshan Maah 2022, the Pediatric and Dietetics Department of Bhaikaka University, in collaboration with the NSS Unit of the University, distributed Nutritious Sukhdi to children and lactating mothers in the pediatric ward. This act of compassion and nourishment exemplifies our commitment to the well-being of our community.

# Extending Healthcare Beyond Hospital Walls

Apart from our hospital in Karamsad, we oversee four primary and secondary care centers in rural regions. The primary health centers, situated in Petlad, Bhadaran, Anand Agriculture University, and Agas, are staffed by Medical Officers, nurses, pharmacists, and visiting hospital consultants who provide weekly services. Patients requiring specialized care are referred to our main hospital in Karamsad, where this year, we served approximately 36,000 patients through these centers.

Located in the tribal region of Sevaliya, our secondary care center offers outpatient services, a Trauma Care Center, operating room, wards, Physiotherapy, Laboratory, and crucial Dialysis facilities. Manned by a Medical Officer, a full-time Gynecologist, visiting consultants from the main hospital, and a team of para-medical staff, the center provided care to over 36,000° outpatients, conducted 199 surgeries, carried out nearly 6,000 investigations, and administered 3,729 dialysis sessions this year. Despite a steady influx of patients at the hospital, we remain steadfast in our commitment to reaching underserved areas. Throughout the year, our experts assessed patients in remote locations, ensuring access to vital healthcare for those who would otherwise find the journey to Karamsad unfeasible.

# Cardiology Diagnostic Camps in Kutch: Healing Hearts, Changing Lives

In a heartwarming partnership between Shree Krishna Hospital and Shree Bidada Sarvodaya Trust, a two-day cardiac check-up camp on September 29, 2022, brought hope to the people of Kutch. A dedicated team of adult and pediatric cardiologists, as well as cardiothoracic surgeons, offered free consultations, ECGs, ECHOs, and medicines to more than 127 patients, including 32 children. 18 individuals, in need of further treatment, were referred to Shree Krishna Hospital.

The New Year ushered in another two-day cardiac screening camp on January 7-8, 2023, extending care to 265 patients from nearby villages. Of these, 205 adults and 60 pediatric patients received life-changing diagnoses from our dedicated medical team.

# Empowering Health and Wellness: A Day of Transformation

In the spirit of fostering well-being and emphasizing the significance of regular health check-ups, we joined hands with GMM Pfaudler to host a Free Health Camp at J. V. Patel Industrial Training Institute on December 29, 2022. Students and staff alike experienced the dedicated care of our medical professionals from the Medicine, Dental, Eye, and ENT Departments. From ear, nose, and throat treatments to vision care, the camp provided essential health services, monitoring blood pressure, weight, and height. Valuable insights on diet, exercise, and weight control were also shared, reaching approximately 280 students and 25 dedicated teaching and non-teaching staff members.

# Empowering the Saviors of Lives: A Training Initiative

Beyond our core missions in healthcare and education, we ventured into a pioneering an initiative to equip public services personnel and the general public with life-saving skills. In partnership with the Dr. Shivani Bhatt Charitable Foundation, we organized training on life-saving procedures on August 21, 2022. This groundbreaking effort aspires to create a community of prepared and trained individuals capable of saving lives during emergencies. Policemen, social workers, doctors, teacher's and other dedicated members of society participated in this enlightening training program, guided by our team of an Intensivists. Together, we are empowering people, one life-saving skill at a time.

# SPARSH 2.0: Expanding Horizons

SPARSH is evolving to focus not only on overt NCD conditions but also on the early detection of pre-diabetes and pre-hypertension, with the goal of reversing them through lifestyle changes.

# The Ashirwad Scheme through SPARSH

In collaboration with the Public Health Foundation of India, SPARSH is extending its reach. A total of 5,859 members have joined the Ashirwad scheme through SPARSH camps, increasing the population coverage from 13.7% to 30%. This initiative offers attractive benefits for both OPD and admitted patients.





#### Empowering NCD Patients with Self-Care Workshops

SPARSH is working with certified yoga health educators to promote yoga among NCD patients. Over 34 sessions from September 2022 to February 2023, 640 beneficiaries have learned basic yoga exercises for managing diabetes and hypertension.

# Context-Specific Diet Counselling for NCD Patients

A survey of 50 villages provided insights into native elderly women's dietary choices. Based on these findings, SPARSH has developed a contextspecific diet chart that will be further refined.

#### Promoting Solid Waste Management

In line with its mission to advance rural and social health, SPARSH is expanding its scope to include components like Solid Waste Management. In collaboration with Zydex Industries Private Limited, SPARSH is piloting organic farming using local solid waste across seven villages. Lessons learned will inform future implementations.

#### Teleconsultations for Improved Care

SPARSH is introducing teleconsultations in collaboration with the Department of Extension Programmes and the Department of Medicine. This initiative targets patients with uncontrolled NCDs, providing video consultations with physicians at Shree Krishna Hospital. To date, 263 patients have benefited from these services, enhancing the reach of quality care.

Research has always been at the forefront of the Mandal's activities. Its educational institutions boast the highest number of publications among all medical colleges in Gujarat. Many students have represented their research on esteemed international platforms.

## **Fund Raising**

The Fund Raising Group focuses on seeking funds for treatment of indigent patients, many of them suffering from life-threatening ailments and not in a position to afford treatment as well as for equipment and facilities. As a norm, it is ensured that no patient goes untreated due to inability to bear the treatment cost. The team remains in touch with donors and donor institutions with a philanthropic inclination, including web portals. Transparency in assigning the funds received and documentation of utilization in the form of regular periodic reports is the rule. Members also appraise individual donors on patient condition, line of treatment, and final outcome. With the generous support of numerous donors, it has been possible to move from strength to strength placing the Hospital on a firm footing with the best equipment and skills in the market, made available to the poor and less-privileged rural families in an affordable manner.

The Aashirwad scheme - a blessing for the indigent patients who come for treatment to our 1000-bed Shree Krishna Hospital, Karamsad mainly from the Ahmedabad-Vadodara belt, other parts of the state as well as neigbouring states - has been extended now to 600 of its patient beds, where free treatment is provided without discrimination of caste, creed, region or faith. Among the 60,000 members registered under the Aashirwad scheme, out-patients receive free consultation by doctors, while in-patients bear only the pharmacy costs -the rest of the health-care services being provided to them free of cost. This initiative is further supplemented by discretionary concessions being provided to needy patients. Part of the support so provided is met from internal accruals, while a sizeable portion of the support pours in the form of generous contributions from corporate and individual donors, philanthropic institutions and well-wishers. We are extremely grateful for this support which has enabled us to do the kind of service to the rural community which fulfills the basic motto of our institution – Solace to the suffering.



### Independent Auditor's Report

To The Members of Charutar Arogya Mandal Report on the Audit of the Financial Statements

# **Opinion**

We have audited the accompanying financial statements of **Charutar Arogya Mandal** ("the Trust"), which comprise the Balance Sheet as at March 31, 2023, and the Statement of Income and Expenditure, the Cash Flow Statement for the year then ended, and a summary of significant accounting policies and other explanatory information.

In our opinion and to the best of our information and according to the explanations given to us, the aforesaid financial statements give the information required by the Bombay Public Charitable Trust Act, 1950 in the manner so required and give a true and fair view in conformity with the Accounting Standards as applicable to the Trust and other accounting principles generally accepted in India, of the state of affairs of the Trust as at March 31, 2023, and its Excess of expenditure over income and its cash flows for the year ended on that date.

# **Basis for Opinion**

We conducted our audit in accordance with the Standards on Auditing (SAs) issued by the Institute of Chartered Accountants of India. Our responsibilities under those Standards are further described in the Auditor's Responsibility for the Audit of the Financial Statements section of our report. We are independent of the Trust in accordance with the Code of Ethics issued by the Institute of Chartered Accountants of India (ICAI) together with the ethical requirements that are relevant to our audit of the financial statements under the provisions of the Act and the Rules made thereunder and we have fulfilled our other ethical responsibilities in accordance with these requirements and the ICAI's Code of Ethics. We believe that the audit evidence obtained by us is sufficient and appropriate to provide a basis for our audit opinion on the financial statements.

# **Emphasis of Matter**

We draw your attention to note 9 of Schedule O of the financial statements which refers to the fully describes the effects of the transfer of the operating activities of the Mandal/Trust to Bhaikaka University (BKU). As referred in the said note, the Agreement/MOU between the Mandal and the University with respect to the consideration to be received by the Mandal from the University for the Usage of the Fixed Assets continued to be held by the Mandal. Accordingly, Trust has charged usages charges towards land and Assets usages from Bhaikaka University amount of Rs. 679.14 Lacs which has been recorded in the financial statements for the year ended 31 March 2023.

Our opinion is not qualified in respect of this matter.

# Management's Responsibility for the Financial Statements

The Trust's Management is responsible for the matters with respect to the preparation of these financial statements that give a true and fair view of the financial position, financial performance and cash flows of the Trust in accordance with the Accounting Standards applicable to the Trust and other accounting principles generally accepted in India. This responsibility also includes maintenance of adequate accounting records in accordance with the provisions of the Bombay Public Charitable Trust Act, 1950 for safeguarding the assets of the Trust and for preventing and detecting frauds and other irregularities; selection and application of appropriate accounting policies; making judgments and estimates that are reasonable and prudent; and design, implementation and maintenance of adequate internal financial controls, that were operating effectively for ensuring the accuracy and completeness of the accounting records, relevant to the preparation and presentation of the financial statement that give a true and fair view and are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is responsible for assessing the Trust's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the Trust or to cease operations, or has no realistic alternative but to do so.

The Trust's Management is also responsible for overseeing the Trust's financial reporting process.

# Auditor's Responsibility for the Audit of the Financial Statements

### SCHEDULE N:

Significant Accounting Policies

### 1. Basis of preparation of Financial Statements

- a. The financial statements have been prepared under the historic cost convention on accrual basis in accordance with the generally accepted accounting principles in India, except otherwise stated.
- b. Government grant is accounted when received.
- c. Funds:
  - I. Corpus Fund: Funds received for general purpose and as decided by the management are credited to Corpus Fund Account. Interest earned on investment of Corpus Fund is credited to the said fund account and transferred to Income & expenditure Account.
  - ii. H M Patel Centenary Corpus Fund: Funds received for meeting the cost of indigent Cancer patients and interest earned thereon are credited to H M Patel Centenary Corpus Fund Account and transferred to Income & Expenditure Account.
  - iii. JTT CAM Corpus Fund: Funds received from Jamsetji Tata Trust for scholarship to MBBS students and interest earned thereon is credited to Jamsetji Tata Trust -CAM Corpus Fund Account and used for scholarships to needy students.
  - iv. Infosys Foundation: Funds received from Infosys Foundation to provide quality, affordable and concessional medical care to the underprivileged and poor among the rural community. Interest earned thereon is credited to said fund account and the entire amount of interest earned is utilised for the said purpose.
  - v. HT Parekh Foundation: Funds received from HT Parekh Foundation to meet operating and administrative expenses of Shree Krishna Hospital of the Mandal, credited to the Corpus Fund under FCRA. Interest earned theron is credited to the said Fund and utilised for the said purpose.
  - d. Donations received from communities/institutions for specific purpose are credited to respective earmarked funds and for other than specific purpose are credited to Income & Expenditure Account. Donation received in kind, in nature of revenue is accounted in the book of account at nominal value Rs.1/- while i.e capital nature is accounted at estimated value.

### 2. Use of Estimates

The preparation of financial statements requires estimates and assumptions to be made that affect the reported amount of assets and liabilities on date of the financial statement and the reported amount of revenues and expenses during the reporting period. Difference between the actual result and estimates are recognised in the period in which the results are known/materialized

### 3. Fixed Assets

Fixed assets are stated at cost.

### 4. Depreciation

Depreciation on fixed assets is provided on the written down value basis at the rates as per the provisions of Income Tax Act 1961 except Life saving medical equipments, which are depreciated at 15% against 40% as per the act. Assets valuing up to Rs.5,000/- are depreciated in the year of purchase, further Depreciation on fixed Assets purchased out of earmarked donation is charged to respective fund account.

### 5. Investments

Investments are carried at cost and provision is made to recognise any diminution in value, other than that of temporary nature.

### 6. Retirement Benefits

a.Contributions to Provident Fund and Superannuation Fund are charged to Income and Expenditure Account.

 Gratuity Liability is determined on the basis of number of years of completed service and the last drawn salary, on actuarial basis as estimated by an independent actuary

 Liability for Leave Encashment benefit is determined on the basis of accumulated leave balance and the last drawn salary, on actuarial basis as estimated by an independent actuary

### Notes To Accounts

### 1. Information about the Trust:

Charutar Arogya Mandal (the 'Mandal') is a Public Charitable Trust, registered under the Bombay Public Trust Act, 1950 (Reg. no. F / 119 / Anand) and the Societies registration Act, 1860 (Reg. No. GUJ/ 91/ Anand). The Mandal provides quality medical education and health care to the rural community equitably with commitment, excellence, and honesty and at affordable cost to their utmost satisfaction through Bhaikaka University which is setup under Private University Act, 2009, Trust being a sponsor body.

Mandal is granted registration under section 12 A (a) of the Income Tax Act, 1961 and its income is exempt under section 11 of the Income Tax Act, 1961. Mandal is also registered with DIT (exemptions) Gujarat u/s 80 G (5) and u/s 35(1)(ii) of the Income Tax Act, 1961 for core scientific research. Mandal has setup a Bhaikaka University under Private University Act, 2009 as a sponsor vide notification No.GH/SH/EPU/2019/949/KH-1 dated September 25, 2019.

The amount payable is Rs.96.73 lacs of which Rs.77.04 lacs (P.Y. Rs.77.04 lacs) has been deposited with the Registrar, Gujarat High Court.
