INTRODUCTION

Charutar Arogya Mandal was formed in the year 1972 as a trust and society with an objective to fulfill lthe healthcare needs of the rural community with the resources that match the quality of medical facilities in big cities, with the same level of commitment, expertise and in a sustainable manner.

This year is the fiftieth year of this organization which has grown monumentally from a humble beginning of a 130 bed hospital and a Nursing School to now a Private university offering more than 57 UG, PG, Diploma and PhD courses through six constituent institutions having about 1300 students. It also manages a 1000 plus bed tertiary care multi-speciality hospital with NABH and NABL accreditations, a comprehensive Cancer Care Centre offering Radiation – Medical and Surgical Oncology with a dedicated facility for Bone Marrow Transplant, a state of the art Cardiac Centre which boasts of offering expertise in treating cardiac patients from a day young infant to an 88 year old lady, a fully equipped Trauma Care with a Critical Care Centre having capacity of 172 beds with ventilators, 4 Health Extension Centres offering primary medical care and a centre providing secondary healthcare with facilities of dialysis, and a community outreach programme that reaches out to 150 villages of Anand, Kheda and Panchmahal districts.

The journey of Charutar Arogya Mandal has been challenging to say the least, but it could not have been otherwise. The vision of our Founder Chairman Dr H M Patel, former Finance and Home Minister, was to provide the same level of care to the underprivileged rural community which otherwise was only in the fate of the urban populace , and to nurture healthcare professionals who would treat them with compassion and expertise.

The dream backed by an undefeatable passion is a reality today, and Mandal through its initiatives has affected lakhs of people in need of modern medical treatment and care.

Since 2019, all the institutions managed by Mandal have become the constituents of Bhaikaka University.



PATIENT CARE

Patient care is the core area of Mandal, the very purpose for which the organization was established. At Mandal, patient care is provided through its 1000 bed NABH accredited multi-speciality Shree Krishna Hospital, Manibhai Shivabhai Patel Cancer Centre, Bhanubhai & Madhuben Patel Cardiac Centre, Dinesh J Patel Bone Marrow Transplant Centre, Waymade Critical Care Centre, Ramanbhai Gokal Privilege Centre and the five extension centres at Petlad, Bhadran, Vitthal Udyognagar, Anand Agriculture University and Sevaliya.

The treatment services of the Hospital are broadly bifurcated into two categories : Ashirwad Services and The Healing Tree Services. The Ashirwad services covers the gamut of services that are meant for the patients coming from economically weaker sections of society through enrolment in the Ashirwad scheme, the families whose annual family income is less than rupees five lakhs, are offered all the general services with heavy waivers and concessions. To extend the benefits to a larger group of community, this year the coverage bracket has been increased from five lakhs to six lakhs per annum. The Krupa Arogya Suraksha – Hospital's own social security scheme is also offered through Ashirwad services. Hospital is empanelled with Government to extend treatment under the PMJAY and MA schemes. In this region, we offer treatment for the highest number of medical conditions under MA & PMJAY schemes as compared to any other hospital.

The significant happenings, events and noteworthy developments of the Hospital with respect to patient care is furnished below.

 In an outstanding feat, an ovarian tumor of 8.5 kg was successfully removed from an old lady of 70 years of age by the doctors of the Obstetric and Gynaec Department. This case is unique by all means considering the fact that



usually ovarian tumors are found in women in their mid forties and the maximum mass would not be more than 500 grams. The patient was discharged after two days of stay in ICU and a few days of ward care.

- The Hospital and the A D Gorwala Blood Centre felicitated distinguished voluntary blood donors and blood donation camp organisers on 1st October 2021 – the National Voluntary Blood Donation Day.
- A week long celebration took place to commemorate World Diabetes Day which falls on 14th November every year. Special talks by experts, debates and poster making competition for students made it a memorable celebration. Special sessions on "Gestational Diabetes" were organized for the community outreach team of SPARSH. Since this was the 100th year of the introduction of Insulin as a treatment modality, a special handbook on "Decoding Insulin" was launched by the department of Medicine.
- The Obstetric and Gynaec department saved the lives of two young mothers who were brought to the hospital in extremely critical condition with Hb levels of 1 and 4.5 grams respectively. Both the patients experienced massive blood loss after their deliveries which made their health condition critical and was deemed as high risk for treatment. However, with collective efforts from the O&G team, the Critical Care team and the Blood Centre, the lives of both mothers were saved.
- In another challenging case, an eight months pregnant lady was brought to the hospital who had contracted the Covid infection. Her condition was constantly deteriorating since more than 50% of her lungs were affected by

infection and her breathing was highly irregular. The teams of O&G and Critical Care decided to intervene planning a pre term c-section to save life of both mother and child. The newborn was sent to Neonatal Intensive Care and the mother was admitted to ICU. After a few days, much to the happiness of the staff, the mother and child were discharged from the hospital in a healthy and happy state.

- On 1st July, our flagship event, National Doctor's Day was celebrated with a sense of pride and gratitude. Doctors were greeted inperson with personalized chocolate bags and greetings, observing the covid safety protocols.
- Hospital organized a multi-speciality camp at Nadiad with joint efforts from Shri Keshav Bhavani Janseva Trust on 15th May 2021. Consultants from Medicine, Opthalmology, Orthopaedics, and Obs & Gynec department attended to over 160 patients who came to this camp. Free ECG and other investigations were done and medicines were provided gratis to patients who came to this camp. The patients diagnosed with cataract in the camps were operated free of charge at our Hospital.
- It was an additional feather in the cap for the cardiac centre as a very rare procedure TAVI (Transcatheter Aortic Valve Implantation) was performed where a valve of a 70 year old patient was replaced non-surgically. This risky and technically challenging procedure is popular in metros. Our Hospital became the first in the Anand Kheda region among the 8 centres offering cardiac treatment with cath labs to replace the valve of the patient without requiring him to undergo bypass surgery. The patient was in a healthy and happy state and was discharged within two days.
- A nine month child from Khargon district of Madhya Pradesh with a hole in her heart



got a new lease of life at our Hospital. Dr Vishal Bhende and his efficient team at the Cardiac Centre performed a highly risky and complicated surgery on the child using a handmade Trileaflet Pulmonary Valve for the first time at our Centre. Excellent post surgical care played a vital role in the recovery of Alisha, whose treatment expenses were covered under the PMJAY.

- The Healing Tree services of the Hospital started offering "Continuous Renal Replacement Therapy(CRRT)", a nephrological life saving procedure. It is a dialysis modality for managing critical patients who are hemodynamically unstable and for whom other modalities are not successful. It is mainly used for managing patients with cardiac and hepatic dysfunction and for whom other routine modalities are not helpful. We are the only centre in and around Anand offering CRRT at the critical centre of THT service.
- Proving its worth in the best manner possible, the CRRT (Continual Renal Replacement Therapy) played an instrumental role in saving the life of a 60 year old female with multiple organ failure. The patient was brought to us after she was diagnosed with Dengue and her condition had significantly deteriorated in another health setup. She was immediately taken to the Critical Care Centre with kidney failure, low blood pressure and liver and heart in a critical condition. With CRRT, and unwavering care from Urology and Intensive Care team, the patient who stayed in the ICU for 90 days, went home in a healthy condition.
- Triplets with extremely low birth weight were given a fresh lease of life at our Hospital with expertise and hardwork of the doctors of Neonatalogy department. The mother of the child was referred to us from a government hospital since she had preterm labour pain

and was in a critical condition due to triplets. After undergoing a c-section, all her three infants were kept in the Neonatal ICU for 41 days and administered Kangaroo Mother Care under close observation of Doctors. The family of these children was very poor and relied on daily wages for running their household. Assessing their financial position, the Hospital supported them for the entire treatment cost.

- We feel proud to mention that our first ever Bariatric surgery was performed on a woman of 54 years. The patient who weighed 111 kg before the operation with a BMI of 50 had a host of other ailments like hypothyroidism, high blood pressure, diabetes, persistent pain in joints and faced difficulties in breathing to the extent that she needed a BiPAP machine while sleeping. She was successfully operated upon at our Hospital and was provided with all post surgical lifestyle and dietary modifications.
- A Cardiac Camp was organized at Bidada, Kutch in association with Bidada Sarvoday Trust. Our team comprising of a Cardiothoracic surgeon, Adult Interventional Cardiologist and a Pediatric Cardiac Surgeon attended to over 200 adult and pediatric patients with cardiac conditions in the camp and the medicines were distributed free of cost by the organisers.
- For the first time at our Hospital, silicon fingers was made available by KMPIP's newly started Prosthetic and Orthotics Assistive Technology division to rehabilitate a patient who lost his fingers in an injury. This implantation restored the functional ability of the hands to the patient and distinctly improved his quality of life.
- An outstanding surgical success was registered when a young man of 30 years with a history of epilepsy was operated upon for removing a cancerous tumor in his liver. The patient was having epileptic fits from the tender age of four.

The tumor was detected when he was unable to eat and had persistent nausea and stomach ache. The highly risky and complicated surgery was successfully administered by a wonderful teamwork from the team of Oncology, Neurology and Anaesthesia.

• A 28 year old labourer from Mangalpura village who was affected with GB Syndrome was saved with efforts of our efficient team of Intensivists. The patient was a labourer and was unloading heavy bags of grains in the shop where he worked. All of a sudden his limbs felt no sensation and he lost control. He was immediately rushed to the emergency section of our Hospital and later to the Critical Care Centre. This patient, a father of two children was not in a position to pay for the treatment so taking into account his financial condition, his entire treatment expenses were waived off. He went back to his home hale and hearty

Covid Care Update

- Shree Krishna Hospital was literally the beacon of hope for the covid patients, right from the time when other healthcare settings were not yet geared up for pandemic. The Hospital maintained its policy of not refusing treatment to any patient, be it covid or non-covid. We laid down meticulously designed protocols for treating both kinds of patients with safety and care, followed the covid safety protocols diligently and we kept on working tirelessly to offer care to all the patients who lined up for treatment in ambulances near our Emergency department.
- We converted our Parking area into a field Hospital to have beds offering primary care for the covid patients who were otherwise waiting in the ambulance for their turn to get a bed.

ANNUAL REPORT 2021-22

Our doctors and other healthcare staff came out and treated patients in Ambulances and the make-shift 50 bedded field hospital. The 102 bedded critical care facility that started functioning for covid patients emerged as a 400 bedded facility exclusively dedicated for covid care. The flow of covid patients remained incessant, and at one point of time we serviced 600 covid patients on a single day.

- The Healing Tree services of the Hospital introduced special services to treat patients safely. Covid Home Care packages were introduced to provide care to patients who did not require a hospital stay, Teleconsultation services were started so that patients could reach out to doctors from the safety of their home, and Covid testing was offered round the clock and all through the week so that patients do not have to wait long for results.
- Our Hospital set up an Oxygen plant with support from AMUL. The plant has a capacity of producing 20,000 litres of oxygen per hour, which can serve 60 patients a day, and was inaugurated on 1st May 2021. The oxygen plant was set up on a war footing and the entire project was complete within a span of 8 days, which otherwise would normally have taken atleast 40 to 45 days. With this plant,



our Hospital became self reliant in fulfilling the need for oxygen for critical covid patients.

• The Hospital also offered treatment to patients with the infection of Mucormycosis

In a nutshell, the unprecedented uncertainty and complexity faced during this pandemic revealed the true character and capabilities of our organization.

Moments of Pride

During the year, we were recognized for our work on various fronts:

- Shree Krishna Hospital was recognised with a Certificate of Appreciation by the Government of Gujarat for outstanding performance in the implementation of PMJAY during the year 2020-2021. Of the 1500 Hospitals in the state implementing PMJAY, 600 are private. Of these private hospitals, only three were honoured for their performance, and our Hospital is one of them. With this award, we are the only one in the district to be honoured with this recognition.
- Shree Krishna Hospital the bagged Times prestigious Economic Healthcare award for Excellence in Hospital Management during COVID-19 at the national level. The Economic Times introduced the first edition of the "Healthcare Awards" to recognize, acknowledge and certify the groundbreaking contributions as the leaders and movers in areas of the healthcare sector. At the India Healthcare Leaders Awards held on October 1 Shree Krishna Hospital was recognized for its efforts and innovations, based on a set of parameters for effective ,efficient and excellent management skills demonstrated during Covid 19.

- Charutar Arogya Mandal was honoured with the Pride of Charotar Award by Nav Gujarat Samay and Ahmedabad Mirror on 24th July 2021. This award was conferred upon us for our exemplary services in the field of medical education and healthcare for the needy sections of community.
- Shree Krishna Hospital bagged an award for "Excellence in Diet Management for OPD patients" by India Association for Parenteral and Enteral Nutrition(IAPEN). This is a first in its kind of award which was announced at IAPEN Nutritional Congress 2021, Ahmedabad. Our Hospital claimed this recognition at the district level.
- Shree Krishna Hospital participated in a Global Group Study which was recognised by the Guinness World Records for "The most authors on a single peer-reviewed academic paper adding up to 15,025". Authors from 116 countries collaborated on this academic paper. This paper was a breakthrough in informed decision making and providing improved safety for patients undergoing surgery during the pandemic.
- AD Gorwala Blood Centre, SKH was recipient of the prestigious certificate from the World Book of Records – London. AD Gorwala Blood Centre received the participation certificate from The World Book of Records, London at a the function held at Ahmedabad on 23rd March, chaired by the Governor of Gujarat. This was in honour of facilitating the largest blood donation drive of the National Integrated Forum of Artists and Activists (NIFAA), for collecting 97,744 blood units.

HEALTHCARE EDUCATION

The healthcare education fostered and nourished by Bhaikaka University brings home a different approach to education per se. Owing to its philosophy of "Instilling purpose in healthcare" the students - the future professionals of healthcare are carefully and meticulously nurtured to practice medicine in a way that restores the innate essence of medicine as a noble and ethics driven profession.

Covid had a very disturbing impact on academics as a whole across all educational Institutions and disrupted a lot of ongoing classroom and clinical training activities. However we were quick to adapt and enabled teaching online sessions with improvisations and value-addition to make education more effective.

Following are the important activities taken up by each Institution during the year:

PRAMUKHSWAMI MEDICAL COLLEGE

- As part of the continuous process of building improvements in online teaching in the future, the Department of Medical Education conducted a study on perceptions of faculty of Pre-clinical and Para-clinical departments regarding online teaching learning activities during pandemic. The faculty reported that they adapted to online teaching quickly, but found limitations in online teaching-learning and assessment.
- An orientation course for the batch of incoming interns was organized on the 14th and 15th of June 2021. The topics for the orientation course included roles and responsibilities as an Intern, Team-work, Basic Communication Skills, Patient Safety, Clinical Documentation using




SOLACE, Basic Life support, and Medico-legal Issues.

- The college organized refresher courses on Covid-19 at regular intervals for PG residents throughout the year. In order to streamline the response to Code Blue and effective CPR, the college organized a training program on Code Blue for first and second year residents of clinical disciplines
- Mechanisms were put in place for Curriculum Governance of MBBS program with constitution of the College Council and various committees like; the Curriculum Committee and Curriculum Sub-Committees. The Curriculum Governance of the MBBS program and MD/MS programs is also aptly supported by the Deans of Academic Services and Internal Quality Assurance Cell of the college.
- The College was granted recognition by the National Medical Commission for an annual intake of 150 MBBS seats for the academic year 2021-22 vide letter dated 20.07.2021.
- As a significant milestone, the total annual intake of MD/MS programs crossed 100 during the period 2021-22 with an intake of 102 students this year.
- Total intake in Super Speciality Courses under the National Medical Commission and National Board of Examinations is 07. The DM Neonatology program started at the college during the year is the first neonatology program in the state of Gujarat, which is a matter of great pride and honour for Bhaikaka University.
- Shree Krishna Hospital is accredited to run Fellowship Programs in Critical Care, Paediatric Intensive Care, and Head & Neck Oncology with a total annual intake of 8. The hospital has

initiated the process of starting Sub-speciality programs in Medical Oncology and a Broad Speciality program in Radiation Oncology.

- The Internal Quality Assurance Cell (IQAC)of PSMC with the Department of Medical Education (DOME), BU organized two workshops on "Implementation of Self-directed Learning (SDL)" and a national workshop on "Planning, Facilitating & Assessing Self-Directed Learning in Undergraduate Medical Education".
- With the introduction of the Ph D programme, we have 15 scholars pursuing various medical specialities, like, Anatomy, Physiology, Pharmacology, Psychiatry, General Medicine, Health Professions Education and Paediatrics.
- The College organized 13 CPD(Continuing Professional Development) workshops and conferences during the year which saw very encouraging participation.
- The Mentorship Program is at present functional in First and Second MBBS with 18 mentors in First MBBS and 27 mentors in Second MBBS. Mentorship policy was revised and the changes included policy on identifying slow and advanced performers and intervention at departmental and mentor levels.
- The College reconstituted committees for, Students Mess, Hostel, Sports and Fitness, Library, Cultural and Community Service initiatives with the appointment of faculty incharge for each committee.
- The Women Development Unit of Pramukhswami Medical College was constituted in December 2021.

- A webinar on "Intellectual Property Rights" was jointly organized by IOAC, KMPIP and Research, Innovation and Extension Group on 26th June 2021.
- Oath taking Ceremony "Diksha": The Oath taking ceremony "Diksha" for the outgoing interns (Batch 2016-20) was held on 1st July, 2021. Ms Swara Yadav was awarded the Gold medal for being the Best outgoing student and for her best performances in academics, sports and cultural activities. Students were also awarded for best seminar and project presentation.
- Certificate Course in Splinting: 19th batch completed the Certificate Course in Splinting in January 2022.
- KMPIP in association with Intas Oncology organized a webinar on "Ill effects of Tobacco" on the occasion of "World No Tobacco Day", 31st May, 2021.

Students enthusiastically performed role plays, dance, created videos and showcased posters reflecting the theme. "Mental health for all let's make it a reality".
- World Diabetes Day was celebrated on 11th November 2021 on the theme "Access To Diabetes Care". An expert session was organized where Dr. Punam Bhende, Assistant Professor, PSMC delivered a lecture regarding diabetic foot examination.
- Organization of the exhibition on Newborn Week Celebration, demonstration of breastfeeding techniques, and screening of newborns was done from November 15 to November 20 by T.Y BSc and fourth-year BSc nursing students. - Farewell of Medical Technology Interns was arranged by CAMIAHST on 18th December 2021.
- The University examinations for PG Degree and Diploma Programs was conducted under Bhaikaka University and 100% results were obtained for PG programs.
- Orientation Program for the undergraduate students was organized on 4th & 5th October 2021. A total of 46 students and their parents participated in the Orientation Program. The Orientation Program for the post graduate students was organized on 18th October 2021.
- A total of 47 students enrolled in UG and 66 students in PG program during the academic year of 2021-22.

- "World AIDS Day" program was arranged in collaboration with NSS unit of Bhaikaka University on 1st December, 2021. The



celebration included blood donation camp & slogan writing competition for all the constitutes of BU. A total of 22 blood bags were collected from the volunteer students of medical technology and physiotherapy at A.D. Gorwala Blood Centre and 19 students enthusiastically participated in the Slogan Writing Competition.

- The "National Youth Day" was celebrated in collaboration with NSS unit of Bhaikaka University on 12th January, 2022. The celebration included the Essay Writing Competition on the topic of "Swami Vivekananda and Education" amongst all the constituents of Bhaikaka University.
- Bhaikaka University, National Service Scheme (NSS Wing) conducted a six-day Annual

Camp from 7-12 March, 2022 at Ashi village of Petlad Taluka. Of the 57 student volunteers from various constituent institutions of the University. 15 students from our Institution enthusiastically participated in various activities like hospitality, ophthalmic camp, blood donation camp, awareness creation for thalassemia, organ donation, women and child care, women empowerment and de-addiction though street plays.

COMMUNITY OUTREACH

The Community Outreach by Mandal is carried out through its unique programme called SPARSH (Shree Krishna Hospital Programme for Advancement of Rural and Social Health), which is implemented in Anand, Kheda and Panchmahal districts and aims at connecting the last person in villages to appropriate levels of healthcare through trained Village Health Workers (VHWs) in their own villages, health centres in towns/villages close by and a tertiary care centre catering to critical cases.

A total of 150 villages are covered by the program. In terms of the population covered, the entire program covers a population of 4.5 lakhs.

SPARSH 150 is focused on the prevention, treatment and care of chronic diseases such as Diabetes, Hypertension, Cancer and chronic respiratory diseases. Various interventions such as camps, school based awareness sessions, community awareness sessions, home delivery of medicines for chronic patients and home visits for bed-ridden patients are undertaken under this program. Due to the Covid-19 second delta wave from March - June 2021, field activities were affected badly for these months. The after effects of this wave still persisted for quite sometime.

During the year, through project SPARSH, 11563 patients were serviced through 604 camps. and 8948 patients received consultation. The awareness sessions in villages could not be done in this financial year post Covid-19 pandemic.

A total of 63172 patients were screened for Hypertension & Diabetes. The average monthly cost of treatment for patients with Hypertension, Diabetes and those having both Hypertension and Diabetes was Rs.38, Rs.86 and Rs.151 respectively.

Summary of new initiatives taken under SPARSH during the year include:

• The Telepsychiatry component had been implemented in collaboration with the Department of Psychiatry. The telepsychiatry





guidelines issued by the Government are being followed strictly. A total of 109 new consultations along with medications had been undertaken this year.

- The Teleconsultation component has been initiated across 100 villages. In collaboration with the Department of Medicine, all enrolled patients of SPARSH had free consultations with the Medicine faculty. From our routine MHT camps, a separate slot for the video consultation was arranged for the patient with the Technical Incharge alongwith the physician and the Assistant Medical Officer present with the patient. A total of 38 new consultations were undertaken.
- Surveys were undertaken on the trends of Covid-19 infection in rural settings during the

second wave. Another survey on Covid-19 immunization status too was undertaken.

- A separate Palliative team had been constituted; comprising of a trained GNM, a social worker and a visiting Medical Officer. The activity was led by an Executive. The emphasis was on strengthening the social care domain.
- Training of VHW's was done to take care of mild/asymptomatic Covid-19 positive patients. As per ICMR, State government guidelines VHW's were trained and a booklet of essential care was developed and distributed among them.
- A booklet on various success stories in SPARSH villages was developed and distributed among the key stakeholders of the villages.





Providing fund support to indigent patients for health-care

Shree Krishna Hospital's Aashirwad scheme is a blessing for the poverty sticken patients as treatment is provided without any discrimination of caste, creed, region or faith at heavily subsidized rates. For the members registered under the Aashirwad scheme, out-patients receive free consultations by doctors, while in-patients bear only the pharmacy costs -the rest of the health-care services being provided to them free of cost. This initiative is further supplemented by discretionary concessions being provided to needy patients falling above BPL norms, and implementation of government health-care schemes. Part of the support so provided is met from internal accruals, while a sizeable portion of the support pours in the form of generous contributions from corporate and individual donors, philanthropic institutions and well-wishers.

These contributions also enable us to strengthen our infrastructure and replace/ modernize our medical equipment.

In recognition of its credibility as well as transparency in reporting its financials and fund-utilization, the Mandal was honoured for the 5th successive year with the Platinum Seal of GuideStar India. Further we have also been endorsed and recognized by Charities Aid Foundation India, Credibility Alliance, Give India and BSE Sammaan. We are empanelled with august bodies such as the National CSR Hub of TISS (Tata Institute of Social Sciences) upto the end of 2023, the United Way of Baroda. We are also acknowledged as an Implementing Agency by the Indian Institute of Corporate Affairs and Indians for Collective Action, IICA.

The COVID pandemic which struck in early 2020 continued to pose a serious threat to the health of the people of the country during 2021-22. During the period from March 2021 to May 2021, the second wave prevailed with ferocious intensity resulting in a multitude of serious cases at the Hospital, and anxieties related to the bedside supply of oxygen and essential medicines. The expansion of the COVID treatment facility taken up in the previous year was further intensified. We are extremely grateful to all the donors who helped us through monetary and in-kind donations to meet this challenge. While monetary and in-kind donations were received in a very timely manner from about 80 donor organisations, noteworthy contributions towards COVID infrastructure came from Tata Education & Development Trust, Azim Premji Foundation, BI Patel Charitable Trust of Elecon Group, SAP (through NASSCOM), The Shanta Foundation UK, Zydex Industries, GMM Pfaudler, Gujarati Samaj of New York Inc. - In response to 49 appeals placed in various publications on behalf of poverty stricken patients, several generous donors came forward contributing Rs 38.3 lakhs in all.
- Totally Rs. 47.06 lakhs was collected from Trusts & Foundations viz., PL Patel Foundation, Shree Jalaram Sevashram Trust, Patel Family Charitable Trust, Gita Jyotindra Patel Memorial Foundation, Kantilal J Shah Charitable Trust, Manilal Harilal Kadakia Charitable Trust, Bai Hirabai J. Report on the Audit of the Financial Statements

Opinion

We have audited the accompanying financial statements of **Charutar Arogya Mandal** ("the Trust"), which comprise the Balance Sheet as at March 31, 2022, and the Statement of Income and Expenditure, the Cash Flow Statement for the year then ended, and a summary of significant accounting policies and other explanatory information.

In our opinion and to the best of our information and according to the explanations given to us, the aforesaid financial statements give the information required by the Bombay Public Charitable Trust Act, 1950 in the manner so required and give a true and fair view in conformity with the Accounting Standards as applicable to the Trust and other accounting principles generally accepted in India, of the state of affairs of the Trust as at March 31, 2022, and its excess of expenditure over income and its cash flows for the year ended on that date.

Basis for Opinion

We conducted our audit in accordance with the Standards on Auditing (SAs) issued by the Institute of Chartered Accountants of India. Our responsibilities under those Standards are further described in the Auditor's Responsibility for the Audit of the Financial Statements section of our report. Emphasis of Matter

We draw your attention to note 9 of Schedule O of the financial statements which refers to the fully describes the effects of the transfer of the operating activities of the Mandal/Trust to Bhaikaka University (BKU). As referred in the said note, the Agreement/MOU between the Mandal and the University with respect to the consideration to be received by the Mandal from the University for the usage of the Fixed Assets continued to be held by the Mandal. Accordingly, Trust has charged usages charges towards land and Assets usages from Bhaikaka University amount of Rs. 679.33 Lacs which has been recorded in the financial statements for the year ended 31 March 2022.

Our opinion is not qualified in respect of this matter.

Management's Responsibility for the Financial Statements

The Trust's Management is responsible for the matters with respect to the preparation of these financial statements that give a true and fair view of the financial position, financial performance and cash flows of the Trust in accordance with the Accounting Standards applicable to the Trust and other accounting principles generally accepted in India. This responsibility also includes maintenance of adequate accounting records in accordance with the provisions of the Bombay Public Charitable Trust Act, 1950 for safeguarding the assets of the Trust and for preventing and detecting frauds and other irregularities; selection and application of appropriate accounting policies; making judgments and estimates that are reasonable and prudent; and design, implementation and maintenance of adequate internal financial controls, that were operating effectively for ensuring the accuracy and completeness of the accounting records, relevant to the preparation and presentation of the financial statement that give a true and fair view and are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is responsible for assessing the Trust's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the Trust or to cease operations, or has no realistic alternative but to do so.

The Trust's Management is also responsible for overseeing the Trust's financial reporting process.

Auditor's Responsibility for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion.

We also provide the Management of Trust with a statement that we have complied with relevant ethical requirements regarding independence, and to communicate with them all relationships and other matters that may reasonably be thought to bear on our independence, and where applicable, related safeguards.

Schedule N: Significant Accounting Policies

1. Basis of preparation of Financial Statements

- a. The financial statements have been prepared under the historic cost convention on accrual basis in accordance with the generally accepted accounting principles in India, except otherwise stated.
- b. Government grant is accounted when received.
- c. Funds :
 - i. **Corpus Fund**: Funds received for general purpose and as decided by the management are credited to Corpus Fund Account. Interest earned on investment of Corpus Fund is credited to the said fund account and transferred to Income & expenditure Account.
 - **ii. H M Patel Centenary Corpus Fund**: Funds received for meeting the cost of indigent Cancer patients and interest earned thereon are credited to H M Patel Centenary Corpus Fund Account and transferred to Income & Expenditure Account.
 - iii. JTT CAM Corpus Fund: Funds received from Jamsetji Tata Trust for scholarship to MBBS students and interest earned thereon is credited to Jamsetji Tata Trust -CAM Corpus Fund Account and used for scholarships to needy students.
 - **iv. Infosys Foundation**: Funds received from Infosys Foundation to provide quality, affordable and concessional medical care to the underprivileged and poor among the rural community. Interest earned thereon is credited to said fund account and the entire amount of interest earned is utilised for the said purpose.
 - v. HT Parekh Foundation: Funds received from HT Parekh Foundation to meet operating and administrative expenses of Shree Krishna Hospital of the Mandal, credited to the Corpus Fund under FCRA. Interest earned theron is credited to the said Fund and utilised for the said purpose.
- d. Donations received from communities/institutions for specific purpose are credited to respective earmarked funds and for other than specific purpose are credited to Income & Expenditure Account. Donation received in kind, in nature of revenue is accounted in the book of account at nominal value Rs.1/- while i.e capital nature is accounted at estimated value.

2. Use of Estimates

The preparation of financial statements requires estimates and assumptions to be made that affect the reported amount of assets and liabilities on date of the financial statement and the reported amount of revenues and expenses during the reporting period. Difference between the actual result and estimates are recognised in the period in which the results are known/materialized.

3. Fixed Assets

Fixed assets are stated at cost.

4. Depreciation

Depreciation on fixed assets is provided on the written down value basis at the rates as per the provisions of Income Tax Act 1961 except Life saving medical equipments, which are depreciated at 15% against 40% as per the act. Assets valuing up to Rs.5,000/- are depreciated in the year of purchase, further Depreciation on fixed Assets purchased out of earmarked donation is charged to respective fund account.

5. Investments

Investments are carried at cost and provision is made to recognise any diminution in value, other than that of temporary nature.

6. Retirement Benefits





- a. Contributions to Provident Fund and Superannuation Fund are charged to Income and Expenditure Account.
- b. Gratuity Liability is determined on the basis of number of years of completed service and the last drawn salary, on actuarial basis as estimated by an independent actuary
- c. Liability for Leave Encashment benefit is determined on the basis of accumulated leave balance and the last drawn salary, on actuarial basis as estimated by an independent actuary

Schedule O: Notes to Accounts

1. Information about the Trust :

Charutar Arogya Mandal (the 'Mandal') is a Public Charitable Trust, registered under the Bombay Public Trust Act, 1950 (Reg. no. F / 119 / Anand) and the Societies registration Act, 1860 (Reg. No. GUJ/ 91/ Anand). The Mandal provides quality medical education and health care to the rural community equitably with commitment, excellence, and honesty and at affordable cost to their utmost satisfaction.

Mandal is granted registration under section 12 A (a) of the Income Tax Act, 1961 and its income is exempt under section 11 of the Income Tax Act, 1961. Mandal is also registered with DIT (exemptions) Gujarat u/s 80 G (5) and u/s 35(1)(ii) of the Income Tax Act, 1961 for core scientific research. Mandal has exemption under section 10(23c) (vi) and (via) of the Income Tax Act, 1961. Mandal has setup a Bhaikaka University under Private University Act, 2009 as a sponsor vide notification No.GH/SH/ EPU/2019/949/KH-1 dated September 25, 2019.
