## Rajesh regains movement

Rajesh, the eldest son of Fatesinh Chavda, lives in Hadgud village of Anand district in Gujarat in a joint family of nine members. Carefree by nature, a school drop-out, Rajesh joined his parents and brother Vipul at work as a daily wage farm

labourer. He married Daksha in 2017. Life has been chequered for the 26 year old youth. Soon after marriage, a road accident - a head-on collision with another two wheeler - left him impaired, despite a few surgeries and several days in the hospital. He walks with a limp and is jobless. Daksha is worried about the future of their two sons, tiny tots, 3 years & 6 months old.

As if this were not enough, recently, one day, he experienced pain in the lower limbs, his legs buckled and his speech slurred mid-sentence. The family could not comprehend the illness. In the next few days, the condition worsened. Brought to Shree Krishna Hospital, Karamsad, he was diagnosed to be suffering from Guillian Barre Syndrome – a rare but serious autoimmune disorder.

He was admitted in the ICU with ventilator support, blood transfusion, higher antibiotics and supportive care. The treatment cost estimate came to over Rs 3.5 lakhs, which the family could not afford. Responding to the family's request for support, and considering the genuineness of the case, the Mandal appealed to donors on their behalf while offering concessions in treatment. Donors supported the cause. After 37 days of successful treatment, Rajesh was discharged. His family expressed gratitude to the Hospital and the donors, without whom, his recovery would not have been possible.

## Vilasben recovers from chronic liver disease

Vijaybhai Parmar is a free-lance mason. His 30 year old wife, Vilasben used

to help him in his work till their first daughter Priyanka was born 7 years ago. Nisha followed a year later. Vilasben was now fully engaged at their small home in Jahangirpura of Village Undel in the coastal Khambhat taluka of Gujarat.

Life went on well. Some time back, Vilasben began having abdominal pain. One day, suddenly she vomited blood, twice in succession. The daughters were shaken. Neighbours informed Vijaybhai who took her to the local medic. The next day, the pain persisted and she had black stools (malena). The family was now really worried. Vilasben was brought to Shree Krishna Hospital and subjected to a series of diagnostic tests. It was concluded that she suffered from hematemesis with chronic liver paranchymal disease – progressive degeneration of liver cells. Nervous, Vijaybhai urged the doctors to save his wife. Doctors explained that the disease was curable, but the treatment cost would be about Rs 3.5 lakhs. Thinking he would lose the battle with the disease as he did not have funds to meet the treatment cost, Vijaybhai began sobbing inconsolably in the passage of the ward. The Mandal came to his rescue. Appeals for help were sent out on his behalf. Help poured in. Admitted in the ICU with Ventilator support, Vilasben underwent blood transfusion, with antibiotics and supportive care. The treatment progressed well. When Vilasben went home fully treated, Vijaybhai expressed his thanks to the Hospital staff and donors for the timely support.

## Parvindarsing wins over 68 % burns

In November 2021, one evening, 10 year old Parvindar was playing with his two brothers along the railway track close to their house in Gurunanakpura area in Mahemdabad. Bored with marbles and tops, they finally decided to fly kites as the breeze was encouraging. After a while, Parvindar's kite got stuck in the overhead cable, but he would not give up. He located a metal rod and tried with rapt attention to dislodge and retrieve the kite. In one such manouvre, the rod touched the HT line. The boy got electrocuted. He was flung to the side with burns on his neck, hands, arms, writhing in severe pain in the limbs. His brothers ran home to beckon their mother. Kiran Kaur, busy chatting with her friend, rushed to the scene with neighbours. Someone located his father Mangalsing- a balloon seller and informed him of the accident. Parvindar was rushed to Shree Krishna Hospital in a serious condition.

He was diagnosed to have suffered 68 % burns, bacterial infections, UTI infection with asymptomatic hyponatremia. Admitted in the ICU, he was to be treated with Albumin, higher antibiotics and intensive care followed by rehab exercises. His family of seven members which includes a mentally unstable uncle is supported by his father. The treatment cost of over Rs 10 lakhs was just beyond their means. Donor support was pooled in. The Hospital provided concession in treatment costs. After nearly two months of treatment, Parmindar went home fully treated. While the scars would take time to heal, his mother Kiran Kaur raises her hands to thank Wahe Guru, the donors and the Hospital staff for saving the boy's life from life-threatening infections due to the burns.

## Key Highlights



### Mandal signs MoU with Farmson Pharmaceuticals for treatment support to poor patients

Fulcrum Vision facilitated the signing of an MoU between M/s Farmson Pharmaceuticals, Nandesari and the Charutar Arogya Mandal for supporting the treatment of 52 indigent patients at the Shree Krishna Hospital, Karamsad as part of the implementation of CSR activity under the health-care segment. GM(HR), Farmson Pharmaceuticals, who visited the Hospital to understand the activities undertaken, appreciated the efforts being made under the Aashirwad initiative.

## Help flows un-interrupted

- Binduben Doshi, ex-President, Inner Wheel Club, Anand Round Town has been providing regular and un-interrupted 'in-kind' support to Thallesemia patients through the Maitri Mandal Trust, for over a decade now in the form of Thalassemia kits. The kit includes a Blood Transfusion set up, IC and Syringes, which are utilized to treat the young patients free of cost, most of them in the age group of 3 years to 11 years.
- Since October 2019, Dr Ilaben & Dr Vinodbhai Shah, USA have been regularly providing medicine support for the treatment of patients suffering from Hypertension, Diabetes and Tuberculosis who come to our Hospital. So far over 500 such patients have been covered.
- Apart from providing generous fund support for the Bone Marrow Transplant Centre of the Hospital, from 2013 to 2015,



since August 2017, Smt Bhaviniben Patel has been regularly donating kits for newborn infants at our Hospital, which are distributed free of cost to each mother. This has benefited 3497 children till date.

- First Cry has been regularly providing kits for new born infants and their mothers coming from the less privileged families since February 2019. So far 2376 kits have been distributed free of cost, eliciting gratitude and contented smiles on the faces of the mothers.
- Since January 2020, the United Way of Baroda has been providing maternity kits to pregnant mothers admitted to our Hospital. So far 1350 kits have been given to the mothers after the delivery of the baby.
- Smt Kumudben Patel, USA provided fund support to the Charutar Arogya Mandal for the Preventive Health Check-up Wing of the Privilege Centre of Shree Krishna Hospital, which was formally inaugurated at a simple function in October 2021.
- The Immunohistopathology lab at our Diagnostic Centre was strengthened with the procurement and installation of a Microtome and a Stainer, thanks to the fund support received from M/s Navin Fluorine under its CSR initiative for health-care. This would help in more precise diagnosis of certain cancers.
