The Voluntary transition of the CEO of the Charutar Arogya Mandal, Shri Sandeep Desai

Shri Sandeep Desai, who contributed to the Charutar Arogya Mandal, for over 2 decades with a passion to ensure equity, access, and affordability in health services and developing people, served his last day as CEO on June 30, 2022.





Kailashben – a brain contusion survivor

27 years old, Kailashben Bilval stays at Nenki Village in the Panchamahal district with six family members. Her husband, Anilbhai, is a daily wage worker in a cattle shed and the only breadwinner in the family. Kailashben has 2 kids, Laksh who is Five years and Vaibhav, 2 years. She has to stay back at home to take care of her children and is unable to contribute in family income.

After the third pregnancy, due to giddiness and sudden loss of consciousness, she fell down at home and had a severe brain injury. As her condition worsened, her family members brought her to Shree Krishna Hospital, Karamsad on March 30,2022.

After the basic tests and examination, she was diagnosed with brain contusion in postpartum period. The treatment required



craniectomy, longer ICU stay, oxygen support, and higher antibiotics. She had been in critical care and on medication for 44 days. Her husband, Anilbhai, borrowed to pay the bills and exhausted all his resources. As the dues mounted, he got worried. He appealed for help, and donor support was garnered, which helped to meet the treatment cost of over Rs 9 lakhs. After 44 days of intensive treatment and care, Kailashben went home, cheerful and healthy. The Anilbhai are indebted to the hospital staff and donors who helped bring his wife back to life.

Almost Paralyzed Harshkumar - springs back

Harsh Pankajbhai Vaghela, a bright 20-year old college student, lives in Surat city with his parents and younger sister Riddhi. His father is working as a sweeper at a local jewellery shop with a meagre income.

At the end of April 2022, Harsh began having breathing difficulties and difficulty gulping water. When it persisted for a week, they went to the village doctor, who dispensed medicines for pain. Harsh took medicine after dinner and went to sleep. The next morning, he could neither get up nor move his limbs. He was terribly tense and got panicked.

The parents were worried. When they brought him to Shree Krishna Hospital as advised by a local doctor, he had breathing problems. Investigations revealed that he suffered from Guillain-

Barré Syndrome, a rare disorder in which the immune system attacks the nerves.



Harsh was placed on ventilator support and on higher antibiotics for about 30 days. As the stay prolonged, his father, Pankajbhai, realized his inability to pay the bills due to meagre resources.


The parents told the doctor that it was becoming difficult to continue the treatment and meet the estimated cost of Rs. 8 lakhs. The Mandal team assessed the family's socio-economic profile and concluded that this was a genuine case for support. The Mandal appealed to donors and donor organisations for support. Harsh was successfully treated and discharged after 54 days of treatment. He has now begun to play with friends. The family is thankful to the Tata Trusts and other donors for helping to save a child's life.

Rinkuben Narendrabhai Dabhi : A young mother returns from the jaws of death

Rinku and her husband Narendra live a simple but happy life with their parents in Mehmdabad village in the Kheda district. Narendra, her husband, and Kanubhai, her father-in-law, work as daily wagers in a local firm. Narendra and his father earn just enough to meet their daily needs, only.

Every evening, Narendra and his father look forward to returning home to their loving family. When the first child was due, the young couple were so happy and consulted a local doctor. Proper care was difficult due to their financial condition. When the pain set in, family members immediately took Rinku to a private hospital where she delivered a baby girl.

However, she could not cuddle the newborn due to weakness and pain. Her stomach became bloated. She writhed in pain. With her



Doctors performed a tracheostomy, she needed an ICU stay, ventilator support, and higher antibiotics. After initially paying for her treatment, Narendra was distraught. He realised that the treatment required was beyond his means.

The Mandal stepped in and helped him appeal to the Tata Trusts, who generously help to save Rinku. The intensivists played a crucial role during her stay in ICU, with ventilator support, for over a month. When the condition of his loving wife stabilised and she was discharged, Narendra was in tears. He was extremely grateful to all who had helped in the return of Rinku from the jaws of death.
