Stories To Rejoice



Kirtipal Solanki

The 14-year-old, Kirtipal Solanki is son of Shri Vijaysinh Solanki who works as a Plant Operator from Kherda village of Anand district. Kirtipal suddenly fell down on his way to home after playing cricket and started stammering. After that episode of fall, he slowly developed difficulty in limb movement and was unable to hold or lift objects. After several episodes of fever and cough, and visits to many local doctors, he was finally brought to the Shree Krishna Hospital.

Our Neurophysician assessed him and carried out a host of investigations. He was diagnosed with Guillain-Barré Syndrome (GBS) - a rare neurological condition attacking the nerve cells. For the treatment, he was hospitalized for 84 days' a group of generous donors came forward for financial aid. Finally, Kirtipal went home in a joyful state, while the teary-eyed parents bid us a goodbye expressing their gratitude towards the hospital and donors.

Ode family lives in Pandoli village of Petlad taluka, Dist. Anand. Ranjanben is a housewife and husband Miteshbhai works in an IT firm. One day, she was riding back to home from the market along with her husband and son Akash. The family met with a serious road accident where Ranjanaben fell from the two-wheeler and immediately went unconscious. She started bleeding profusely from the nose, and on the other hand, her husband and son also got several injuries.

They were brought to the Trauma Centre of Shree Krishna Hospital where she was urgently intubated and a CT scan was carried out. Reports suggested that she was having Subdural Hematoma – a kind of bleeding inside the skull and cerebral edema. Immediately, Craniotomy was performed on her, followed by a Tracheostomy. After these lifesaving procedures, she was shifted to the ICU for further treatment.

After paying the initial bills of treatment, we observed that her father-in-law was extremely worried about further costs. Since the cost of treatment of patient's husband and son were also to be borne by him, Ranjanben's father-in-law requested the Mandal for help. After analyzing the socioeconomic background of the patient, Mandal extended its support with the help of its donors. After 79 days of close observation and treatment, Ranjanaben was discharged; she went back to her home, thanking the supporters and staff.
