STORIES TO REJOICE



Urvashi Vijay Thakor

4-year-old Urvashi, daughter of Vijaybhai Thakor from Dharmaj village, Anand, was admitted to a local hospital for respiratory distress and referred to Shree Krishna Hospital in a critical phase. After an initial assessment, she was shifted to the Paediatric ICU (PICU) on the diagnosis of Pneumonia and infection in lungs.

Her parents were concerned about the treatment cost and requested support. Financial support was extended with the help of donors. After 37 days of treatment, Urvashi was discharged, and her family expressed gratitude to the team, doctors, hospital, and donors for their support.

Master Dharmik, a 05-month-old from Matar village in Kheda district, was affected with cough, cold, high-grade fever and, breathing difficulties. When his parents took him to a hospital nearby, he was referred to Shree Krishna Hospital, Karamsad. After the initial assessment, he was admitted to the Paediatric ICU. He was diagnosed with a Lower respiratory tract infection with Down's Syndrome, respiratory failure, and severe Pulmonary Arterial Hypertension (PAH).

He was treated with ventilator support, higher antibiotics, nutrition management, and supportive care. His father, a laborer, requested for support. It was taken care of by the Mandal's generous donors and well-wishers. After 26 days of hospitalization, the child returned home happily, and his parents thanked the donors and caregivers for their support.

12-year-old girl Sandhya Talpada from Napa village in Borsad taluka experienced fever and abnormal movements. Her parents took her to the local hospital, but saw no improvement even with medication, later she was referred to Shree Krishna Hospital, Karamsad in a critical condition. The pediatrician was consulted, and it was found that she had Dengue Meningio Encephalitis and pneumonia. She was treated with heavy medication, with ventilator and, physiotherapy support.

Her father, a laborer, requested support for further treatment, which was extended with the help of donors after evaluating their socioeconomic status. After a lengthy stay and treatment of 85 days, she was discharged and returned home. Her parents expressed

gratitude to the hospital and the donors for their support.



Areez Khambatta Benevolent Trust donates equipment for the Neonatal ICU


